

Voluntary Release, Waiver, Assumption of Risk, and Indemnity Agreement ("Agreement")

In consideration of my participation in the 5K Run Through the Orchards sponsored by SOAR, Inc., to be held at the Tierra Rejada Walnut Grove Ranch, 3370 Sunset Valley Rd., Moorpark, and all activities associated therewith (the "Event"), the undersigned for myself, my personal representatives, heirs, next of kin, spouse and assigns DO HEREBY:

1. Release, Discharge and Covenant Not To Sue SOAR, Inc., SOAR Nonprofit, Walnut Grove @ Tierra Rejada Ranch, LLC and owners Rick and Linnea Breconier; Sun Valley Farms, LLC and owners Mark, Deborah and Lynn Cassar and Nad Hugh, their officers, directors, agents, Trustees, contractors, employees, volunteers, shareholders and insurers (all collectively referred to herein as "Releasees") from any and all claims, loss, liability, damages, or expense related to the Event in any way, arising out of any wrongful or negligent acts or omissions on the part of Releasees or any other person or any other cause whatsoever, which may cause me injury, death, damages of any kind. I hereby covenant to defend Releasees, hold Releasees harmless, and to indemnify Releasees for any claim, loss, liability or expense (including, without limitation, attorneys' fees and costs which Releasees, or any of them, may incur) in connection with the Event or arising out of my activities.
2. Understand that running, walking or participating in a foot race is a potentially hazardous activity. My participation is voluntary and I Voluntarily Elect to Accept All Risks connected with my participation, including, but not limited to falls, contacts with other participants, the effects of the weather, including high heat and/or humidity, traffic and the conditions of the road, all of such risks being known and appreciated by me.
3. Represent that I know of no physical disorder which should keep me from participating in the Event and I agree that I AM SOLELY RESPONSIBLE for any and all injuries or harm that I may incur in participating in the Event.

I HAVE READ THIS DOCUMENT AND UNDERSTAND IT IS A RELEASE AND WAIVER OF ALL CLAIMS OR RIGHTS TO FILE A LAWSUIT OR OTHERWISE RECOVER FROM RELEASEES. I HAVE BEEN GIVEN TIME TO CONSIDER WHETHER TO SIGN THIS RELEASE AND TO REVIEW IT WITH MY OWN COUNSEL, AND HAVE EITHER DONE SO OR VOLUNTARILY ELECTED NOT TO DO SO. I HAVE VOLUNTARILY SIGNED MY NAME SHOWING THAT I ACCEPT THE ABOVE PROVISIONS. I ACKNOWLEDGE THAT I CAN RUN 5 KILOMETERS (3.1 MILES) OR WALK 3 KILOMETERS (1.5 MILES). I GRANT PERMISSION TO ALL OF THE FOREGOING TO USE ANY PHOTOGRAPHS, MOTION PICTURES, RECORDINGS, OR ANY OTHER RECORD OF THIS EVENT FOR ANY LEGITIMATE PURPOSE.

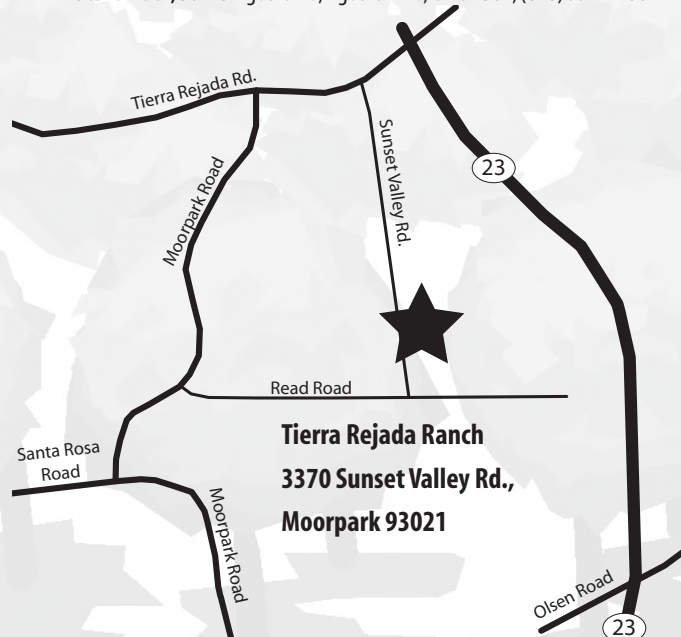
